That we, Hugh Hollande of Pennant in the town of Erethlyn in the County of Denbigh, gentleman, Henry ap Jevan Lloyd of Hafod Ynnos in the county aforesaid, esquire, Owen Hollande of Berrow Isafe in the county of Anglesea, esquire, Robert Hollande of Erethlyn aforesaid, gentleman, and John Hollande of Erethlyn aforesaid in the county aforesaid, gentleman,

Are held and firmly bounden unto Owen ap Hughe ap Owen of Bodeone in the County of Anglesey, esquire,

In the sum of one thousand pounds of good and lawful money of England, to be paid to the same Owen ap Hugh ap Owen, or his true attorney, or his executors, administrators or assigns,

To which payment, indeed, well and faithfully to be made, we firmly oblige ourselves, and each of us by himself for the whole and separately, and our heirs, executors and administrators, by these presents, sealed with our seals,

Given on the eighteenth day of the month of May in the thirtieth year of the reign of our Lady Elizabeth, by the grace of God, of England, France and Ireland, Queen, defender of the faith etc, 1588
